What is this research about?

The research project is being conducted by a group of researchers led by Associate Professor Wesley Imms of the Melbourne Graduate School of Education at The University of Melbourne. This project has been approved by the University of Melbourne's Human Research Ethics Committee (Program reference: 1647284; Project reference: 1749099).

The research project forms part of the Innovative Learning Environments and Teacher Change (ILETC) project, to investigate the use of innovative learning environments (ILEs) in schools. It responds to a broad research question, Can altering teacher mind frames unlock the potential of innovative learning environments?

What will I be asked to do?

Should you agree to participate, you are invited to complete an online survey about innovative learning environments. The aim of the online survey is to get teachers' perspectives on their transition from traditional learning spaces into more innovative learning environments. Specifically, the survey will ask respondents about the types of spaces they use and how these impact their teaching. The online survey will take approximately 8 minutes.

What are the possible benefits?

Your contribution is vital to a greater understanding of how we can support Australian and New Zealand teachers to effectively use learning spaces in schools to affect student learning. The project intends to provide information and tools to help support teachers working in and transitioning into ILEs.

Data will be collected, used and stored in accordance with both New Zealand and Australian privacy laws. The data will be kept securely at the University of Melbourne and Qualtrics data centre in Australia (encrypted, password protected and only accessible to named researchers) for five years from the completion of the larger ILETC project (including publication and public release) and will be destroyed after this time.
